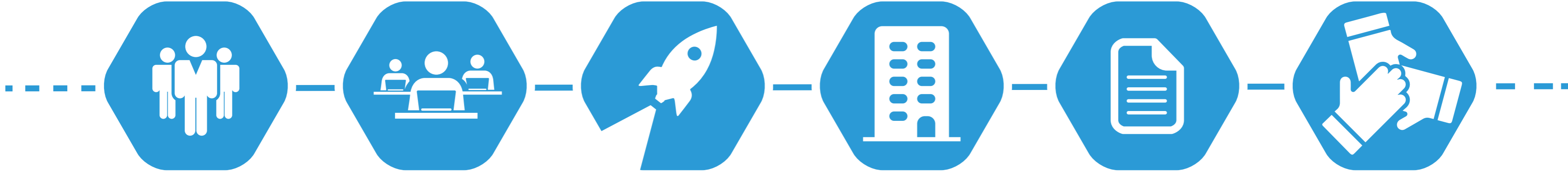

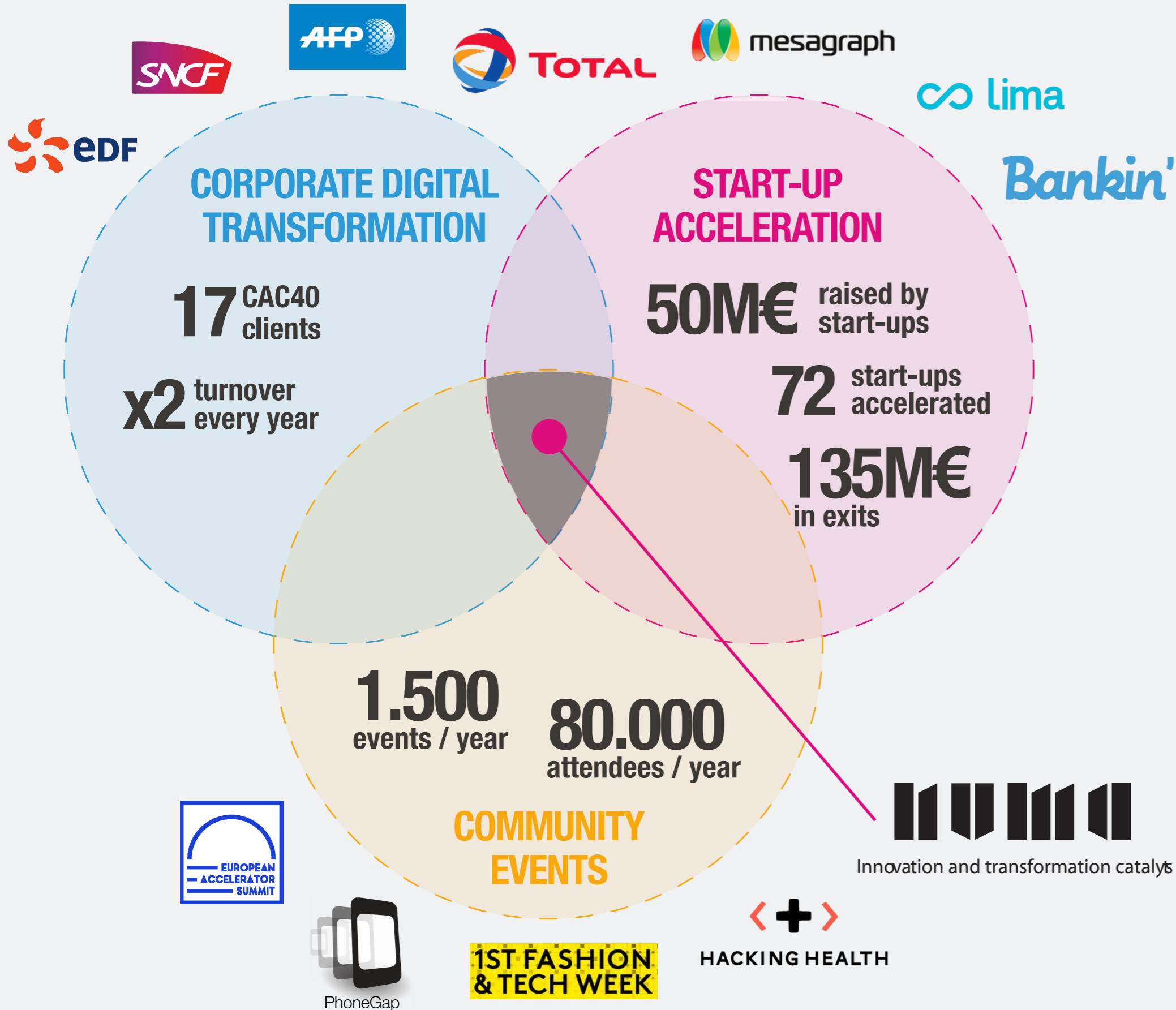

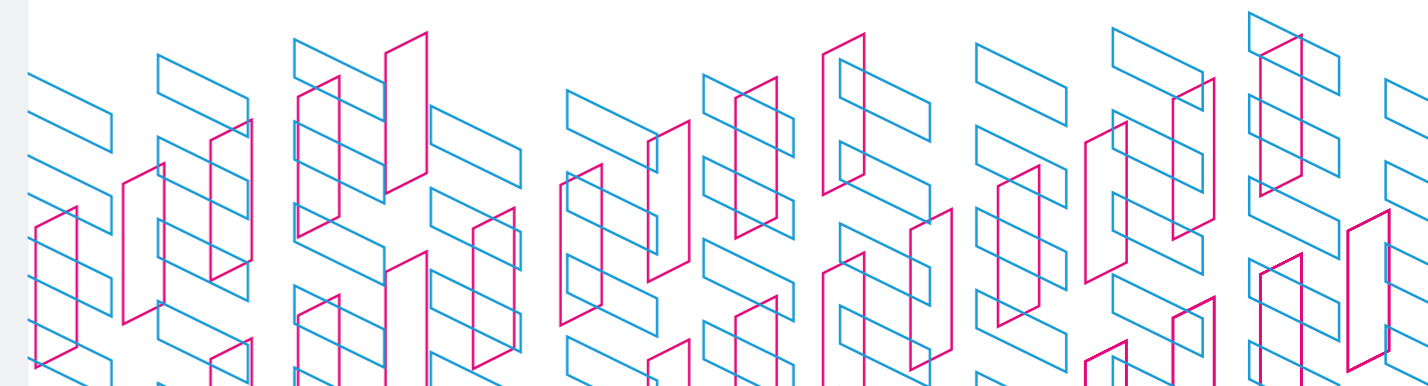

NUMA AT THE HEART OF THE TECH ECOSYSTEM

In 2014, NUMA has gathered more than 80 000 visitors, organized about 1500 events (barcamps, workshops, conferences, summits, hackathons...) and has cooperated with many international companies in their digital transformation. Some of the startups accelerated at NUMA have known very successful exits: Mesagraph (Twitter), DocTrackr (Intralinks) or Kawet (Publicis)



NUMA SUCCESS STORIES



Sketchfab is a marketplace for 3D files (more than 300,000 files are on their website), and is becoming the go-to place for designers and creators to browse and share 3D files. They raised \$7 million in Series A round led by FirstMark Capital in June 2016.

With an advertising technology based on analyzing hashtag, Mesagraph was able to awaken the interest of Twitter, which in 2014 acquired the French start-up 2 and a half years after leaving the NUMA Sprint (season 1)!



After passing through Sprint NUMA (season 1), then at TechStars, DocTrackr is acquired by IntraLinks for \$10 million.

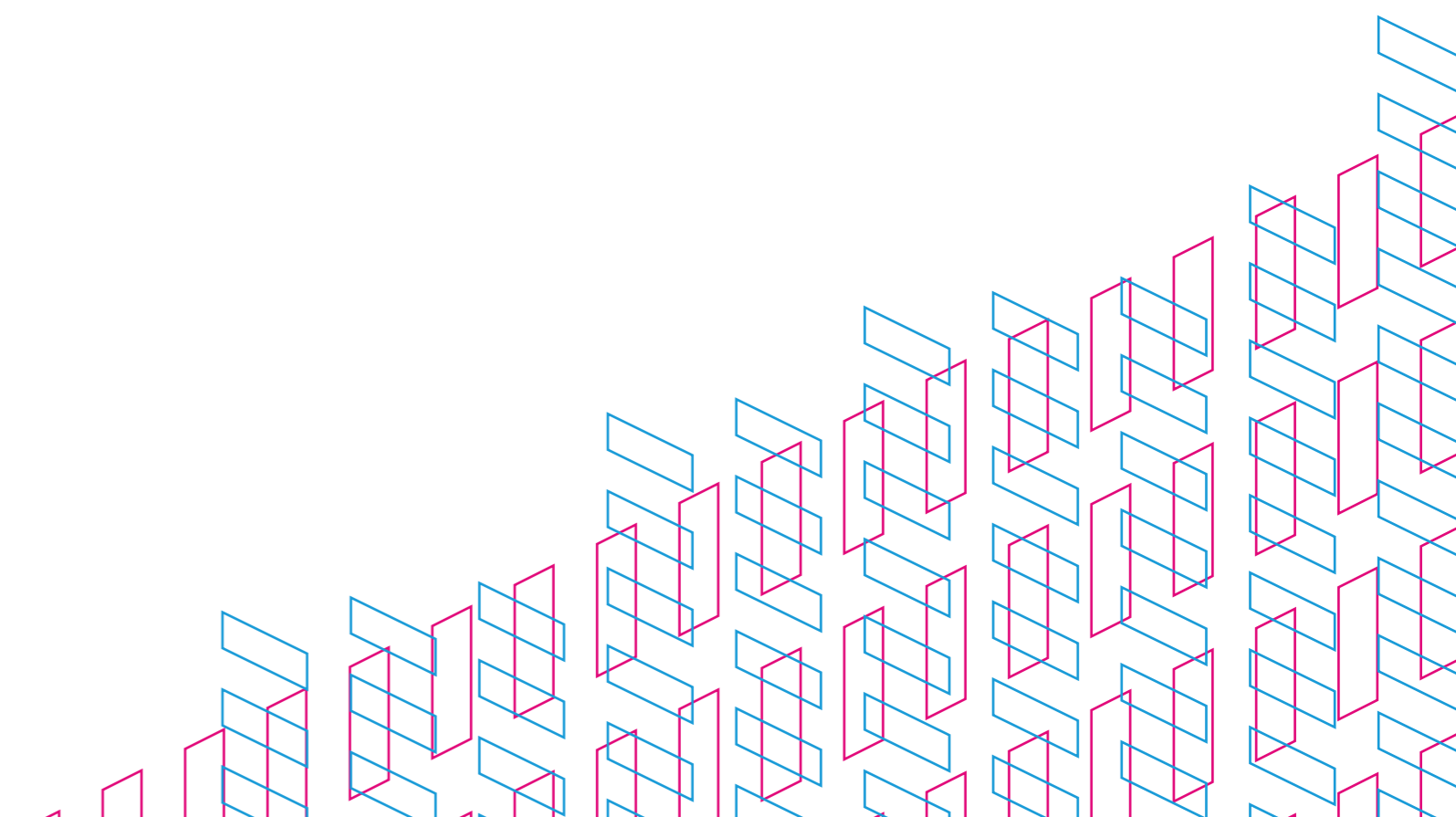

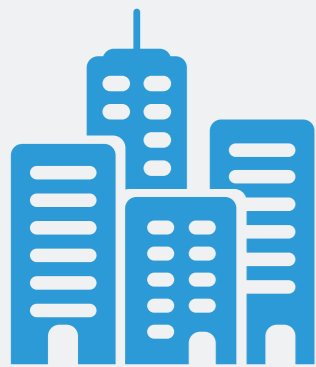
EXPORT OUR MODEL INTERNATIONALLY.

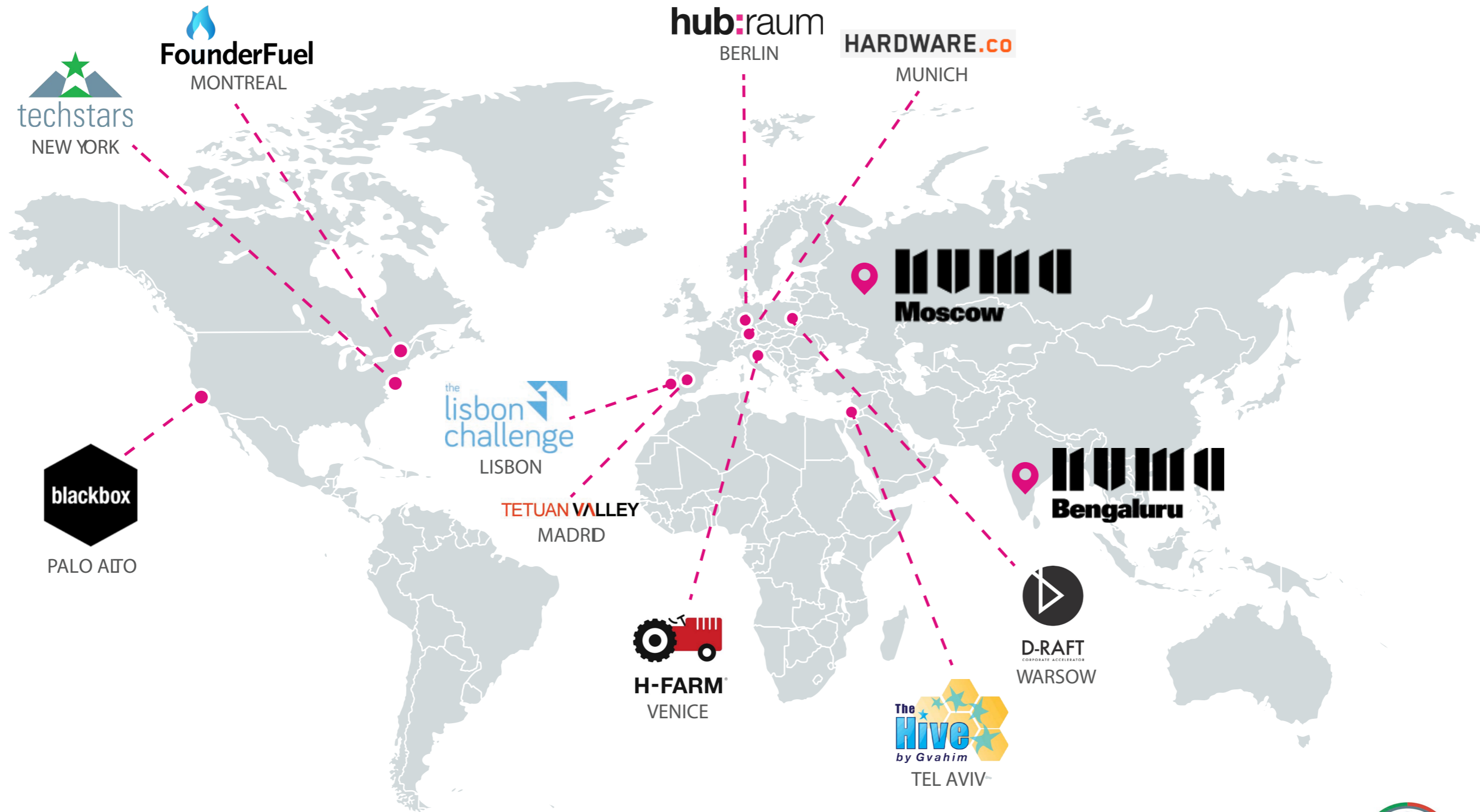

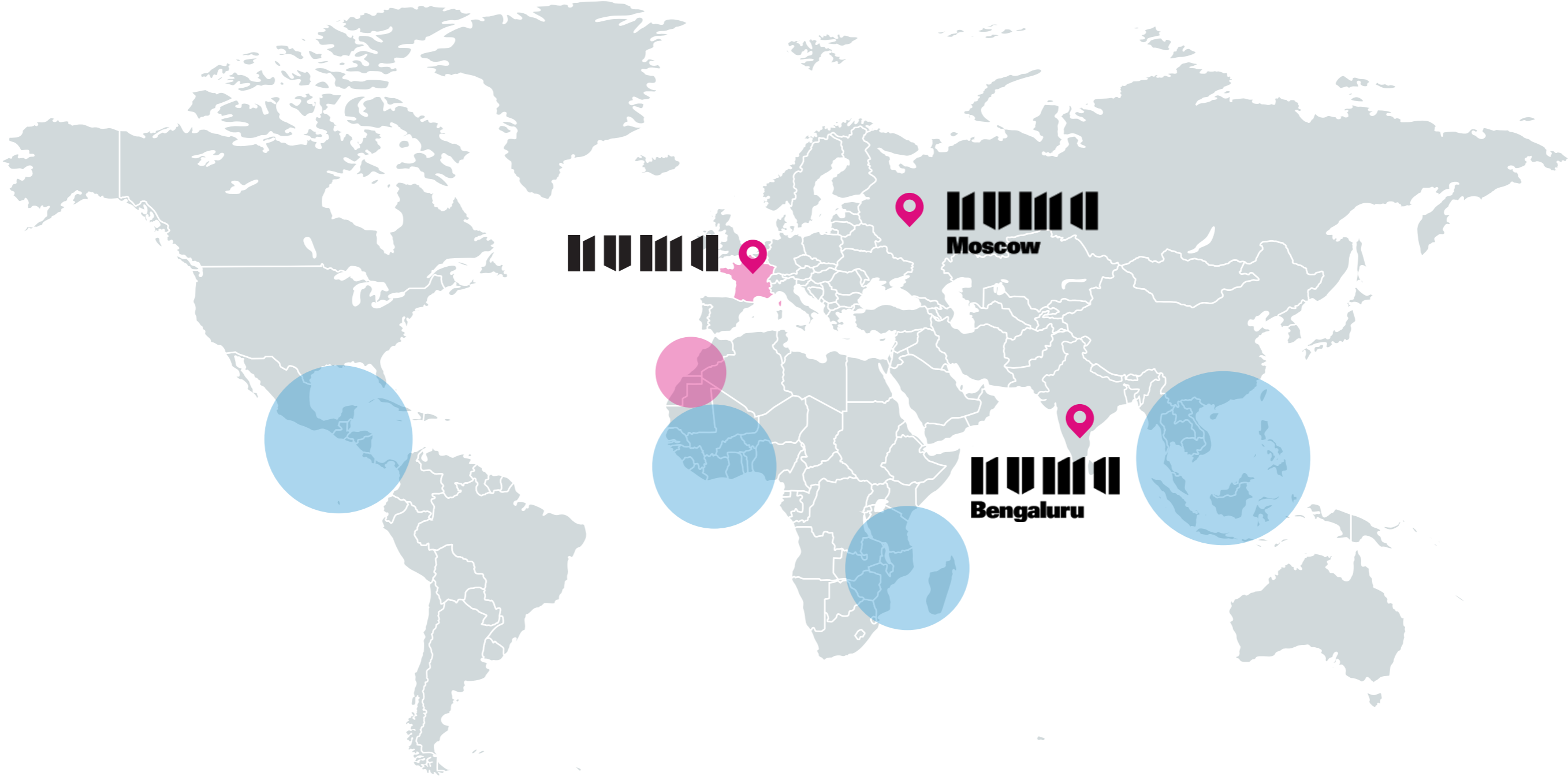
NUMA: ALREADY A STRONG INTERNATIONAL NETWORK*

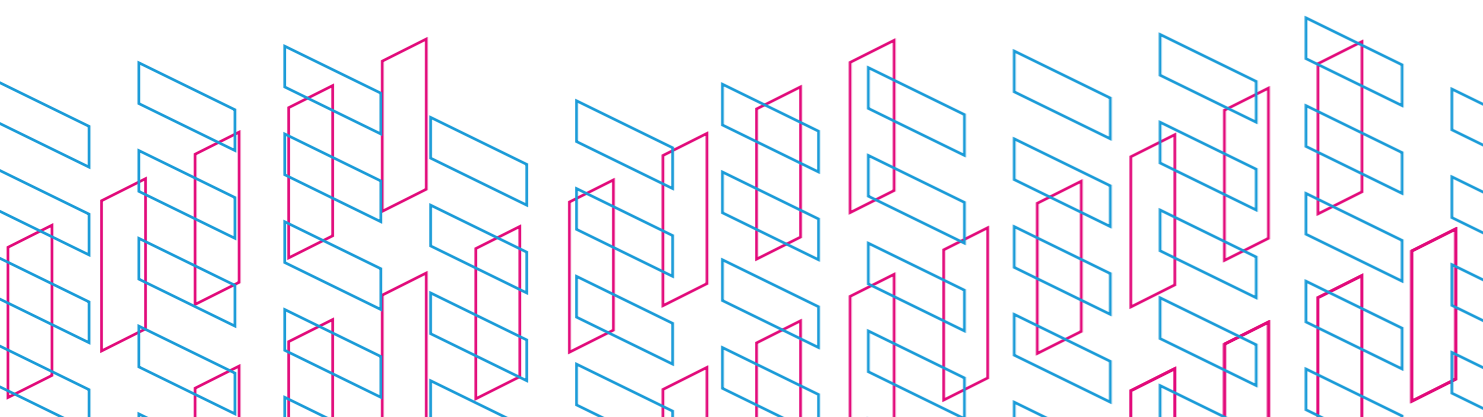
